## Bring your dog to run and play!

Canines are pack animals and socialized creatures (as are we humans!), and Canine Corners is a great place to let your dog off the leash to play, run, and socialize.

The Rockford Park District provides dog owners with two locations for Canine Corners – Searls Park in west Rockford and Elliot Park in east Rockford (with two enclosed areas). These parks are open year-round from dawn to dusk, and they are fenced so that dogs are safely contained off-leash, with brush and paths for a great field experience.

An annual or semi-annual pass (in the form of a visible dog tag) is required of all dogs using the park, and owners are subject to fines ranging from \$50 to \$500 for non-compliance with user fees or park rules, according to District Ordinance Section 11.03.



## Dog Park User Fees

**FULL SEASON TAG (January–December)**

\$25 (\$35 non-resident); \$15/additional dog

**HALF SEASON TAG (July–December)**

\$12.50 (\$17.50 non-resident); \$7.50/additional dog

**ONE-DAY POOCH PASS**

*If you have a visitor with a dog, this is a good option – only available at the Customer Service locations listed below;*

\$3 for one dog, \$1 for each additional dog

## What You Need to Bring

Proof of current rabies vaccination is required at the time of registration, including a copy of the paperwork from your veterinarian. Owners are required to sign a rules, waiver, and release contract.

## Canine Corners Rules

To ensure that owners and their pets have a great time while visiting Canine Corners, there are a few rules that all users must abide by.

- Tags are required to use Canine Corners (annual or semi-annual user fee).
- Children under age 10 are not permitted in Canine Corners.
- Your dog must be under your control and in your sight at all times.
- You are held responsible for your dog's behavior.
- The Rockford Park District has the right to refuse or revoke tags of dogs displaying aggression or intimidating behavior towards other dogs or people. No refunds will be given for revoked tags.
- Dog owners are responsible for picking up and disposing of all their dogs' waste.
- No food and no smoking.
- Male dogs must be neutered.
- Female dogs in season are not permitted.
- All dogs must be leashed when entering and leaving the park.
- Dogs less than 4 months of age are prohibited.
- Spiked, pronged, and pinch collars are prohibited within the dog parks.

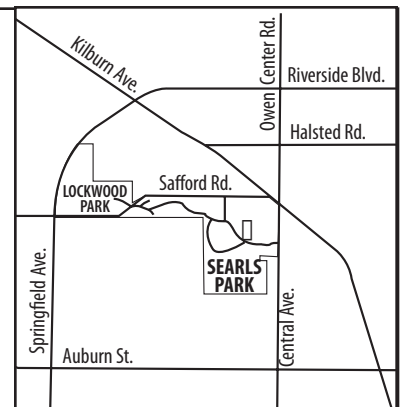
### ELLIOT Location

Located just off Lyford Rd. in Elliot Park in southeast Rockford (accessible from the Maintenance Shop entrance). There are two fenced 2-acre areas with parking nearby. Shelter is provided in the south area; water is available in the north area.



### SEARLS Location

Located within Searls Park in northwest Rockford, opposite the baseball diamonds. It is a eight-acre fenced-in area, four which are wooded and trail filled. Parking is located in front of the park, and water is available at the shelter.

**IMPORTANT INFORMATION**

You are solely responsible for supervising your dog and determining whether or not this is an appropriate activity to participate in. You must understand that you are participating in this activity at your own risk (and risk of your dog). Dogs and permit holders of varying degrees of skill, training and experience use this facility. You are solely responsible for determining if you and/or your dog are physically fit and/or adequately skilled to use this facility. It is always advisable, especially if you or your dog are pregnant, disabled in any way, or recently suffered an illness, injury, or impairment, to consult a physician or veterinarian before undertaking any dog training or exercise activity.

**WARNING OF RISK**

Dog activities are intended to provide a fun and rewarding experience for a dog and its owner. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including death to either the dog or its owner. Dogs are pack animals and when "off lead," even the best-trained dogs will act instinctively. Understandably, not all hazards and dangers associated with dog activities can be foreseen. Certain inherent risks include the propensity of any dog to behave in dangerous ways that may result in injury to another patron or dog. Other risks include, but are not limited to, the inexperience, negligence or irresponsibility of a dog owner; the inability to predict a dog's reaction to sound, movements, objects, persons, or other animals; and actions by the dog due to fright, anger, stress, insect bites, or natural reactions such as jumping, pulling, resisting and biting. Other risks include the hazards associated with environmental and traffic conditions, acts of God, inclement weather, slip and falls, premises defects, equipment failure, failure in instruction/supervision, and all other circumstances inherent to dogs and outdoor activities. Should you attempt to break up a fight between dogs, you may be attacked and severely mauled by the other dog or attacked by the dog's owner/handler. In this regard, it must be recognized that it is impossible for the Rockford Park District to guarantee absolute safety.

**WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK**

Please read this form carefully and be aware that in consideration for permission to use this facility, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your dog might sustain as a result of participating in any and all activities connected with and associated with use of this facility and surrounding area. I recognize and acknowledge that there are certain risks of physical injury to the dog and its owner/handler in association with participating in dog activities, and I voluntarily agree to assume the full risk of any injuries, damages or loss, regardless of severity, that I might sustain as a result of participating in any and all activities connected with or associated with use of this facility and surrounding area. I do hereby agree to waive, relinquish, release and forever discharge the Rockford Park District, including its officials, agents, volunteers and employees (hereinafter collectively referred to as "District") from any and all claims for injuries, damages or loss that I may have or which may accrue to me and arising out of, connected with, or in any way associated with this use of this facility and surrounding area. I further agree to indemnify and hold harmless and defend the District from and against any and all losses, claims, damages, liabilities, cause of actions, and expenses (including attorney fees), on account of personal injuries or death to any person or dog, or damages to property occurring, growing out of, incident to, or resulting directly or indirectly from my use of this facility and surrounding area.

**I have read and fully understand the above important information, dog park rules, warning of risk, assumption of risk, and waiver and release of all claims. If registering on-line or via fax, my on-line facsimile signature shall substitute for and have the same legal effect as an original form signature.**

**PHOTO/VIDEO AUTHORIZATION, CONSENT AND RELEASE OF ALL CLAIMS**

I hereby authorize and give my consent to the District to photograph/video me, my minor child/ward, and my dog(s), and without limitation, to use such photographs/video in connection with promoting/advertising the services, programs, and facilities of Rockford Park District without consideration of any kind. Such productions may be copied, copyrighted, edited, and distributed by the District in the manner described above. I understand that my, my minor child's/ward's, and my dog(s) name, likeness, or voice may be used in the manner described above, and grant the Rockford Park District the right to use and reuse, in any manner at all, the video, motion picture, audio recording, web page, social media pages, or still photograph productions, and broadcasts as described above.
